Eviction notices and fraudulent legal filings mailed using USPS.

Certified legal documents sent to Berkshire's legal team were received and ignored.

3. Use of False Documents in Court - 18 U.S. Code § 1001

Submission of falsified lease documents (bearing Berkshire logos and seals) in eviction proceedings.

4. Obstruction of Justice – 18 U.S. Code § 1512

Berkshire Hathaway claimed "franchise independence" (similar to McDonald's), but:

Contracts were generated using Berkshire's software and corporate seals.

The eviction was enforced under a Berkshire-signed lease.

Employees used @bhhscal.com email domains and authenticated DocuSign links.

Hanson Le generated and enforced a forged lease.

2. Grand Theft (PC § 487)

Rent payments accepted and not returned despite fraudulent termination.

3. Elder Abuse (WIC § 15610.30)

Eviction of disabled mother-in-law during a pending lease with legal protections.

4. Conspiracy (PC § 182)

Collusion between owner, agent, and possibly neighbors to evict for short-term profit.

5. Real Estate Fraud (PC § 532f)

Misrepresentation of contract status and deliberate omission of extensions already signed.

6. Unlawful Business Practices (B&P Code § 17200)






