The Rabbit Hole of Fraud & Liability



(Every step deeper = more exposure, no way out)

LEVEL 1: DIRECT FRAUDSTERS

Hanson Le – Associate Broker

Actions: Counterfeit lease, demanded funds to private bank account, intercepted payments, took 5th Amendment.

Violations: Wire Fraud (18 U.S.C. §1343), Mail Fraud (§1341), Forgery, Extortion (CA PC §518).

Time: 20–30 years per count (federal).

Anna Ly – Realtor

Actions: Advertised fraudulently (pets, washer/dryer, ocean view), unilateral contract void, fraudulent DocuSign, extortion for \$500 early fee.

Violations: Wire Fraud (§1343), False Advertising (Bus. & Prof. Code), Extortion (PC §518).

Time: 20 years per wire fraud count.

Phat Tran – Owner/Doctor

Actions: Directed eviction, accepted fraud, concealed payments, lied in court, planned Airbnb conversion.

Violations: Perjury (18 U.S.C. §1621), Fraudulent Conveyance, Tenant Retaliation, Elder Abuse (§368 PC).

Time: 10–20 years federal + state penalties.

LEVEL 2: LEGAL ENABLERS

Steven Silverstein – Eviction Attorney (“Eviction King”)

Actions: Filed knowingly false documents, concealed notices, accepted fraudulent move-out form, ignored certified mail evidence.

Violations: Subornation of Perjury (18 U.S.C. §1622), Mail/Wire Fraud conspiracy, Candor to Tribunal violations.

Time: 20 years federal + disbarment.

Richard Rosiak – Defense Attorney (30 years)

Actions: Took \$8,000, abandoned client pre-trial, repeated pattern since 2018, concealed evidence, refused to return work product.

Violations: Wire Fraud (§1343), Legal Malpractice, Abandonment, State Bar ethics violations.

Time: Disbarment, prison exposure on fraud charges (20 years).

LEVEL 3: CORPORATE SHIELD

Berkshire Hathaway HomeServices (Franchisees & Franchisor)

Actions: Provided letterhead, contracts, software; ignored multiple certified notices; failed to discipline Hanson/Anna.

Violations: RICO (18 U.S.C. §1962), Willful Blindness, Franchise liability.

Time: Civil RICO treble damages + corporate penalties.

David Beard – Chief Counsel

Actions: Received pre-eviction notice of fraud, failed to act, liability shield collapsed.

Violations: Aiding & Abetting (§2), RICO participation.

Martha Mosier – President, BHHS CA

Actions: Received warnings, ignored, allowed rogue franchises to proceed.

Violations: Supervisory liability under RICO.

THE MATH – PUNISHMENT ESTIMATES

Wire Fraud: 20 years per count (Hanson/Anna/Rosiak/Tran).

Mail Fraud: 20 years per count.

Perjury/Subornation: 5–10 years per false statement (Silverstein/Tran).

RICO: 20 years + treble damages (corporate).

Elder Abuse: Up to 4 years state + enhancements.

Est. Totals:

Hanson: 150–300 years (multi-count wire/mail fraud).

Anna: 100–200 years.

Phat Tran: 80–150 years.

Silverstein: 50+ years + disbarment.

Rosiak: 50+ years + disbarment.

Berkshire (corporate): Treble damages, federal oversight, franchise losses.

MESSAGE TO JURY / FBI / COURT

Each actor knows the others.

Each had notice (letters, certified mail, emails).

Each failed to stop it, dragging them deeper into the rabbit hole.
