- This format does three things:
- 1. It sets a trap: if Tran denies aliases, you impeach him with CheckPeople and public record reports.
- 2. It ties aliases directly to fraud predicates (mail fraud, wire fraud, forgery).
- 3. It reinforces the jury theme: your facts vs. his cover story.
